#### **ECB DBS Update Service Improvements**

In January 2023, the ECB introduced some improvements to the way our DBS application system integrates with the Disclosure and Barring Service (DBS) Update Service. The improvements will streamline the registration and annual check process for both volunteers and paid applicants and will ensure the ECB has the most up to date information regarding the roles people are undertaking in cricket.

All the above improvements are now live, and no specific action is required by the individual until their certificate is due for the annual recheck.

# FREE Safeguarding e-Learning for all in cricket

The ECB have just launched 2 new FREE safeguarding e-learning courses:

## 1. 'Introduction to Safeguarding' (Induction) (Level 1)

The 'Introduction to Safeguarding', is the ECB's new online safeguarding course for all individuals in the game. This is available for everyone involved in cricket. With this in mind we invite you, and everybody at your club or organisation, to complete the online "Introduction to Safeguarding". The training provides basic knowledge and advice in creating a safe cricket environment for everyone, recognising signs of abuse, what to do if you have any concerns or if you are approached by anyone with concerns that they may have. This training should take around 30 minutes to complete and is accessible on a laptop, tablet or mobile phone.

Those who have already undertaken safeguarding training in their roles such as Coaches and Safeguarding Officers, they <u>are not required</u> to complete this course, although individuals may do so if they wish

### 2. 'Safeguarding for Specialist Roles' (Level 2)

The new course, 'Safeguarding for Specialist Roles' replaces Safeguarding Young Cricketers (SYC) e-Learning and is designed to support individuals in cricket who are working with children and young people. 'Safeguarding for Specialist Roles' is made up of one 60-minute module, suitable for everybody in specific roles in cricket and four shorter bolt-on modules:

- Safeguarding for Coaches and Activators
- Safeguarding for <u>Captains and Team</u> Managers
- Safeguarding for Umpires and Scorers
- Safeguarding for <u>Committee Members &</u> Club Safeguarding Officers

It is considered a requirement of role, so individuals in these specialist roles are invited to complete the one-hour module, followed by the shorter module that best reflects their role.

If you already have an in date SYC, there is no requirement to complete this e-Learning at this stage

Please note that anyone who had the old SYC already assigned to them via ECB e-learning portal have been automatically enrolled onto "Safeguarding for Coaches and Activators"

There has been an important change in legislation. It is currently an offence in England and Wales for anyone aged over 18 years in a position of trust to engage in sexual activity with a child in their care.

In June 2022 the roles included in the definition of position of trust were extended to include anyone who "coaches, teaches, trains, supervises or instructs on a regular basis in a sport ...".

Where someone is in a 'Position of Trust' then the age of consent rises to 18 years. This very welcome change in the law extends legal protection particularly to 16- and 17-year-olds who are participating in sport.
