Safe Hands Guidance

Since the start of the season the ECB Safeguarding Team have been reviewing and updating Safe Hands Policy, Guidance and Templates such as Club Safeguarding Policy, Social Media Guidance and Supervision Ratios.

Confirmation will be sent out once all these documents are available to view and download from the ECB website. This will be in time to allow Clubs to adopt them at their AGM's, we anticipate these to be available during November 2023.

DBS requirements for Scorers

Currently the ECB Safeguarding and Officiating Teams are reviewing the role of Scorer against the requirements of DBS.

Considering the role definition and the legal definition of regulated activity, the ECB will be making a policy decision on the DBS requirements in scoring in early 2024. We are being supported by an internal and external working group which will provide clarity in the months ahead. This update is not being shared beyond the county network until such time as decisions have been made.



Any changes will be shared firstly with the county network before being shared widely across the game well ahead of season 2024.

ECB Safeguarding Courses

It has come to our attention that a few county websites (example below) are stating that the new safeguarding courses which carry a 3-year accreditation period can be completed at any time before the accreditation expiry by way of a refresher:

"I already have an SYC and I am not due yet, can I complete the course anyway? – Yes, Doing so will reset your compliance and you won't need to complete this course again for another 3 years"

Please note, the above example is incorrect, and the course can only be completed by way of a refresher, 1 month before it is due to expire. We kindly ask that you amend your websites to reflect this.
